TERMS AND CONDITIONS

- 1) In order to qualify for a referral fee:
 - a. Both Broker and Agent must be duly licensed in the state in which the Property is located from the time of this registration through the closing of the Property;
 - b. **Completed Buyer Broker Registration Forms, along with Prospect’s signature, must be submitted by Broker or Agent in one of two ways: (1) via fax to (917) 210-2901; or (2) by email to info@prusa.com** (Buyer Broker Registration Forms submitted by any other method, along with incomplete forms or oral registrations, will not be honored);
 - c. Broker or Agent must attend and register with Prospect at the auction; and
 - d. Broker or Agent must fully and timely comply with the terms and conditions outlined herein.

- 2) No referral fee will be paid to a broker whose agents, employees or immediate family members are participating in the purchase of the Property.
- 3) Referral fees will only be paid at the closing of the sale of the Property purchased by Prospect, after the purchase price has been paid in full.
- 4) No Buyer Broker Registration Forms will be accepted after Friday, August 16, 2013.
- 5) Broker and Agent will hold harmless and indemnify Auctioneer and any agents, employees or licensees of Auctioneer from any and all claims with regard to such referral fees due or paid.
- 6) The payment of the referral fee set forth herein pertains ONLY to the Property.
- 7) Broker is not a subagent of Auctioneer and specifically represents Prospect as a buyer's broker or agent.
