## TERMS AND CONDITIONS

- 2) No referral fee will be paid to any broker whose agents, employees or family members are participating in the purchase of the Property.
- Referral fees will only be paid at the closing of the sale of the Property purchased by Buyer, after the purchase price has been paid in full.
- 4) No Buyer Broker Registration Forms will be accepted after 5pm EST on Friday, May 6, 2016.
- 5) Referral fees are based on the High Bid and do not include Buyer's Premium, if any.
