TERMS AND CONDITIONS

1) In order to qualify for a referral fee:

- a. Both Broker and Agent must be duly licensed in the state in which the Property is located from the time of this registration through the closing of the Property;
- b. Broker and Agent must abide by the REBNY Code of Ethics;
- c. **Completed Buyer Broker Registration Forms, along with Prospect's signature, must be submitted by Broker or Agent in one of two ways: (1) via fax to (516.558.1148); or (2) by bringing the completed form to a scheduled open house.** (Buyer Broker Registration Forms submitted by any other method will not be honored. Incomplete forms and oral registrations will not be honored.);
- d. Broker or Agent must attend and register with Prospect at the auction; and

- e. Broker or Agent must fully and timely comply with the terms and conditions outlined herein.
- 2) No referral fee will be paid to a broker whose agents, employees or immediate family members are participating in the purchase of the Property.
