- b. Completed Buyer Broker Registration Forms, along with Buyer's signature, must be submitted by Broker or Agent by email to info@prusa.com (Buyer Broker Registration Forms submitted by any other method will not be honored. Incomplete forms and verbal registrations will not be honored.); and
- c. Broker or Agent must fully and timely comply with the terms and conditions outlined herein.

The parties agree to submit the dispute to 1 (one) arbitrator chosen pursuant to AAA Rules. This shall be the sole remedy for any resolution of a dispute and the parties hereby consent to the exclusive e
